## **Pool Report**

- 1. Pool Repairs Related to Plastering Classic scheduled for this Thursday or Friday.
- 2. Backflow Assembly Replacement Leaking Repair complete, cover installed. A. Hernandez checked prices for protective cage (\$350-\$400) and installation (\$500). D. Sauer believes a cage would not work due to concrete in area. She also reported that Bruce installed a vandal-p roof frost cover over the assembly. It was suggested reflective tape would be helpful; she will ask Bruce to do this.

#### **New Business**

- 1. Winter Rye Planted Completed. Reports of water run-off was noted. A. Hernandez reported that due to the shape of the area there will always be some run-off.
- 2. Complete Landscaping Bi-weekly Winter Proposal Discussion held about cutting back service during the winter months to save money. (Like we do for the pool). New Complete service contract is \$935 per month for April through October (9 hours weekly). \$510 per month for November through March (4.5 hours weekly). All other costs remain the same. Motion was submitted by V. Tapia and seconded by A. Hernandez to approve new agreement from Complete to go to a Winter/Summer Service Contract (\$935x7 months and \$510x5 months) passed.
- 3. Website Calendar Homeowners request we add monthly meetings to calendar.

- 1. Street Chip Seal a) Sweep to remove excess chips not complete, no date scheduled yet to finish.

She found three internet companies (accuform.com; roadtrafficsign.com and safetysign.com) that have a variety of signs. (No poles or hardware included) R. After discussion it was noted that we need to replace two stop signs, we need to add two "children playing" signs and four yield signs.
